### FOREWORD: HOW I GOT HERE

I did not set out to investigate [Victor Marx](#) because I believed him to be a criminal. I set out to investigate him because I did not know what he was. I am a fifth-generation Coloradan, a registered Republican, and a private citizen who pulls public records available to anyone willing to dig. I am not a journalist with institutional protection. I am not a federal investigator with subpoena authority. I am a researcher who started this work because a man was running for governor of my state and something about him did not add up.

From the beginning I held three competing theories, cycling between them as new evidence arrived.

The first was that Marx was a [Pied Piper](#) candidate, a figure deliberately seeded into a primary to draw a specific voter base away from a stronger candidate and ensure a predetermined outcome. In Colorado's 2026 Republican gubernatorial primary, the concern was that Marx was drawing the evangelical, America First, and MAGA base away from [Scott Bottoms](#), whose grassroots support was real, deep, and growing. The beneficiary would be [Barb Kirkmeyer](#), who carried establishment backing and was considered the more manageable option by those who preferred a predetermined outcome.

The second theory was simpler and more cynical. Marx was so convinced of his own mythology that he genuinely believed he could win. The man who claimed to have rescued 45,000 women and children, who claimed the Pentagon called him the day he announced his candidacy, who claimed Charlie Kirk was his mentee, who showed up at Kirk's memorial within hours of the assassination and turned the grief of a [widow into campaign material](#). . . that man may have simply believed his own story.

Everything that follows in this document came after that text. Haiti came after that text. The IDF conversation, the long range rifle request. The underground bunker . . . the afternoon Charlie Kirk was murdered – all of it came after that text.

From the moment I understood what Corby Hall was describing, I was no longer investigating a gubernatorial race. The race is settled. **Victor Marx is not going to be the Governor of Colorado.**

**What I am now documenting is something else entirely.**

## **I. CORBY HALL AND THE FOLDAR**

Corby Hall is the inventor, founder, and sole owner of [FoldAR](#), a Texas-based firearms development company. By way of his patented folding technology, developed over twenty years, FoldAR manufactures full-capability rifles that fold to fit inside a standard backpack and deploy within seconds while retaining full ballistic performance. The weapon has been described by its inventor as the most concealable long gun ever created. Law enforcement and government agencies have adopted it for precisely that reason: it allows an armed officer to be present in a civilian environment without the visible profile of a standard rifle.

Corby Hall's stated mission is school security. His company's stated mission is to arm every school resource officer in America with a weapon that can respond to an active shooter in seconds, from concealment, without alarming students in ordinary circumstances. That mission, and his faith in it, is the thread that runs through everything that follows.

Corby Hall is not a political figure. He is not a researcher or journalist. He is a firearms inventor and manufacturer from Texas who, on March 28, 2026, sent a text message to a researcher in Evergreen, Colorado because he had found a GPS tracking device on his vehicle and believed

Victor Marx had placed it there.

What followed was an extended series of conversations in which Hall provided a certified timeline, a formal written statement, documentary evidence, and eventually his full name and permission to use everything publicly. The one protected element in this account, at Hall's specific request, is the current status of his marriage to Melody Hall. What this document states is that Victor Marx interfered inappropriately in that marriage in a manner that no legitimate pastoral or spiritual advisor would consider acceptable.

Corby Hall still believes, in part, in Victor Marx's stated mission. He has rationalized much of what he witnessed as possibly being State Department or CIA sanctioned. I understand why he needs to believe this. What I am asking you to do is not accept his interpretation. I am asking you to read what he documented that he saw, heard, and experienced firsthand.

## **II. THE RELATIONSHIP: DECEMBER 2023 THROUGH APRIL 2025**

### **December 1, 2023 — First Contact**

At Victor Marx's request, Corby Hall and his then-girlfriend Melody drove from Texas to Colorado Springs to demonstrate the FoldAR at Marx's home-based gun range. The visit lasted eleven hours. During the demonstration, Marx approached Hall separately and asked him to create a [signature series rifle bearing Marx's name](#). He told Hall that the [FoldAR](#) was the only weapon system that made sense for his purposes.



After the demonstration, Marx and his wife Eileen invited Hall and Melody inside. Marx stated he felt the hand of God on them and that God had revealed an abundance was coming their way. Eileen identified what she described as a unique connection between the couple and asked why they were not married. When they explained that marriage was not a current priority, the Marxes began asking personal and religious questions. Hall shared the story of how, at sixteen years old, he had been briefly and falsely identified as a person of interest in the Columbine massacre of 1999.

Marx and Eileen left the room together for several minutes. When they returned, Marx stated that Eileen had dreamed the night before that they would be part of a greater mission to protect children, and that placing the FoldAR on the backs of school resource officers across America was that mission. The coincidences, Marx said, were too powerful to ignore.

Marx then performed what he called a retooling prayer on both Hall and Melody. This practice requires its own examination, addressed in detail in Section VI below. Two FoldAR weapons were given to Marx that day. An eleven-hour visit had established what Marx would later call a deep spiritual bond. What it actually established was Marx's access to the weapon, to its inventor, and to his wife.

### January 24, 2024 — SHOT Show, Las Vegas

At SHOT Show 2024, the firearms industry's largest annual trade show, the Victor Marx Signature Series rifle was released publicly. Marx attended the FoldAR booth for several hours each of the four days of the show. The Signature Series was built around the FoldAR Compact Weapon, selected by Marx specifically for its unprecedented concealment capabilities. Concealment was listed as mandatory in the product description.

On January 24, 2024, Victor Marx officiated the marriage of Corby Hall and Melody in his hotel room, with several firearms industry friends present. The man who had performed a spiritual ritual on them six weeks earlier now stood before God and bound them in marriage. He had become, in the language of their faith community, their spiritual father and covering.

### July 2024 — The National Broadcast Commitment

Marx appeared on [Sebastian Gorka's America First](#) program on Newsmax with Melody Hall to publicly commit to placing a FoldAR on the back of every school resource officer in America, starting with Texas. All Things Possible Ministries purchased five FoldAR weapons for Lindale High School in Texas. No further participation by ATP was ever made or offered, and no explanation was given.

In Hall's retrospective assessment, it was becoming apparent by this point that Marx had no genuine intention of pursuing the school resource officer mission. The commitment had served its purpose. It



was made on national television. It had generated goodwill, credibility, and donor interest for ATPM. And it had deepened Corby Hall's trust in the relationship at precisely the moment that trust was most useful to Victor Marx.

**Fall 2024 — Henderson, Texas: The Haiti Request**

Marx flew into Henderson, Texas to tour the FoldAR manufacturing facilities.

During this visit, standing in Corby Hall's own facility, Victor Marx told him directly that he needed fifty rifles for a mission to Haiti, where he would drop off and leave the firearms. His stated purpose: to go to Haiti and kill [Jimmy Cherizier](#).

Jimmy Cherizier, known as Jimmy Barbecue, is not a local criminal. He is the most

powerful warlord in the Western Hemisphere. He controls approximately 80 percent of Port-au-Prince, Haiti's capital city. He has been designated a Specially Designated National by the U.S. Treasury's Office of Foreign Assets Control since December 10, 2020. That designation means U.S. citizens are legally prohibited from conducting transactions with him or for his benefit without a specific government license. The State Department offers [five million dollars](#) for information leading to his arrest. He is indicted in U.S. federal court. He has been linked to massacres in which civilians were burned alive.

Hall told Marx this would constitute illegal exporting. Haiti was under an active [United Nations arms embargo](#). He advised Marx not to do it with any other firearms. He asked what good dropping off a bunch of rifles in Haiti would accomplish. Marx offered no meaningful response.

Hall then suggested an alternative: go and have a conversation with the man. Marx responded that this was a great idea.

This exchange is the foundation of Corby Hall's belief that he talked Marx out of violence and into negotiation. The evidence does not support that interpretation. By the time of this conversation, Cherizier had already extended a personal invitation to Marx to visit his stronghold. The trip was already planned. Corby Hall's suggestion gave Marx a diplomatic framing to use publicly. It changed nothing about what Marx was going to do.

At this time, Marx had access to approximately twenty FoldAR concealment weapons from prior transfers. Whether those weapons were subsequently transferred to any other party would be, in Hall's assessment, untraceable.

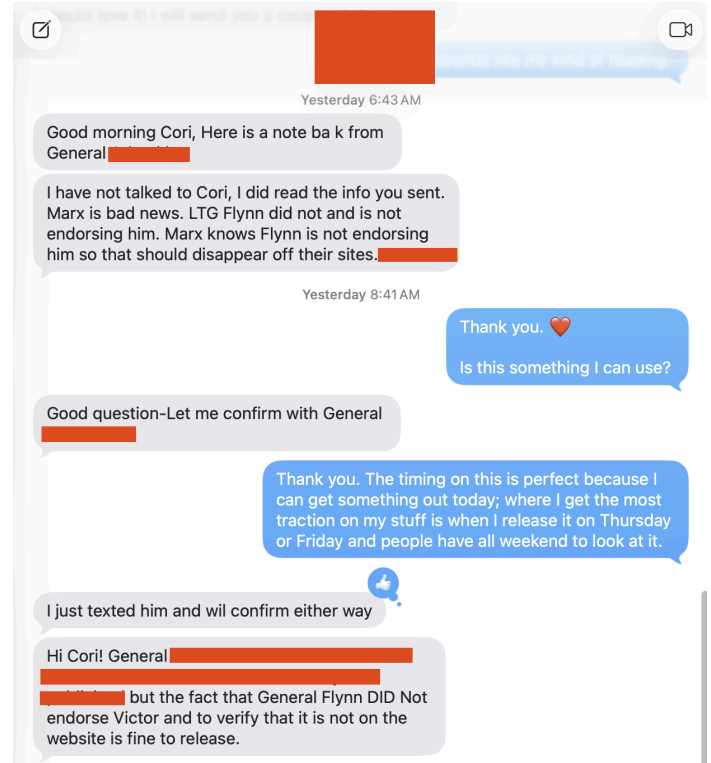

## November 2024 — The Weapon to Daniel Horner

Marx told Hall he had sent one FoldAR weapon to [Daniel Horner](#) of Sig Sauer, the world champion competitive shooter and Sig's top sponsored athlete, for testing and evaluation as part of a potential acquisition discussion. Hall accepted this at face value. It kept him engaged in the relationship and believing that significant commercial outcomes were within reach.

He has claimed 45,000 rescues that no independent body has ever verified. He has told Corby Hall that his weapons operations are sanctioned by the State Department and CIA without producing a single document to support that claim. The statement that a weapon went to Daniel Horner at Sig Sauer is Marx's unverified claim to Hall. No shipping record, no Horner confirmation, and no Sig Sauer statement has ever independently verified it.

In February 2025, Horner's name appeared on the ATPM weapons order, assigned a Victor Marx Signature Series rifle at \$2,799. Whether Horner received any weapon, whether he and Marx had any real Sig Sauer acquisition conversation, and whether Horner even knew his name was being used in discussions with Hall is entirely unknown. Horner has never publicly mentioned Victor Marx. Sig Sauer has never publicly mentioned Victor Marx.

---

### **October/November 2024 — The Long Range Rifle**

Marx invited Hall to his Colorado Springs home and asked him to bring a rifle configured for one thousand yard engagements, with a scope and a mounted scope camera. Hall built the rifle to those specifications and drove to Marx's house to deliver it.

A one thousand yard configuration is not a defensive weapon. It is a precision long distance engagement weapon. A standard defensive rifle is configured for close to medium range. Marx specified the one thousand yard capability. He knew what he was asking for. The scope camera was not standard. A scope camera records what the shooter sees through the scope. Marx had already told Hall he intended to use the video as propaganda. He was not asking for a defensive tool. He was asking for a documentation system attached to a killing instrument.

Marx was not a gubernatorial candidate at this time. He was the founder and CEO of All Things Possible Ministries. A private citizen. A nonprofit leader. There was no political accountability structure around him, no party oversight, no electoral scrutiny. He was a man with a compound in Colorado Springs, a gun range, an armed team, access to untraceable concealment weapons, and a stated intention to either shoot people scaling a fence or capture and execute a U.S.-sanctioned terrorist.

Upon Hall's arrival, Marx explained that his team was packing gear to leave for Haiti shortly. He said the long range rifle and its scope camera would be used to shoot anyone attempting to scale the orphanage fence and that the video would be used as propaganda to deter gang attempts. Hall objected. He said he would not leave the rifle if Marx intended to kill a random person with it. He suggested using a watermelon instead. Marx eventually agreed in what Hall described as a slightly annoyed manner.

Marx then said his team was going in to capture or execute Jimmy Barbecue. Hall suggested negotiation again. Marx appeared to accept.

### ***Corby Hall departed and left the long range configured sniper rifle with Victor Marx.***

That rifle has not been publicly accounted for since. It was not on the February 2025 purchase order. It was a custom-built one thousand yard configuration with a scope camera left at a private compound in Colorado Springs weeks before its owner traveled to meet the man he had previously said he wanted to kill. Its current location is unknown.

---

### **November 2024 — Haiti: What the Public Record Shows**

[Marx traveled to Haiti in November 2024](#). What happened there is documented because Marx described it himself publicly and because CBN News covered the trip with embedded correspondent Chuck Holton.

Before examining that coverage it is necessary to establish what Chuck Holton is in this context. Holton is not an independent journalist covering Victor Marx. He traveled as part of Marx's team. He was embedded with the operation.

Three months after the Haiti trip, Holton's name appeared on the February 20, 2025 ATPM weapons order, assigned a personally engraved FoldAR Compact Weapon designated ATPM Haiti Team during an active UN arms embargo. Chuck Holton is a participant in the operation he reported on. The CBN article describing the Haiti trip as a humanitarian mission was written by a man who subsequently received a personally engraved weapon from the organization whose humanitarian mission he covered. That is not journalism. That is a participant writing a press release.

With that established, here is what the CBN account says. According to CBN, Marx traveled to Haiti at Cherizier's personal invitation. No independent source has confirmed this from Cherizier's side. Cherizier gives interviews routinely to Reuters, NPR, Al Jazeera, CNN, and dozens of other outlets. He has never publicly mentioned Victor Marx. The invitation framing exists solely in the CBN article, which was written by a member of the team.

What is independently confirmed is that Marx met personally with Jimmy Cherizier in Cherizier's stronghold in one of Port-au-Prince's most dangerous neighborhoods. Marx and his team then traveled to Ganthier to meet with Lanmo San Jou, leader of the 400 Mawozo gang.

Lanmo San Jou is indicted in U.S. federal court for conspiracy to commit hostage taking and hostage taking, in connection with the October 2021 kidnapping of seventeen Christian missionaries in Haiti, including five children, one as young as eight months old. The hostages were held at gunpoint for sixty-one days. The gang demanded ransom. The State Department offered up to one million dollars for information leading to San Jou's arrest. The FBI added a separate reward. The 400 Mawozo gang, which San Jou leads, controls the Malpasse border crossing between Haiti and the Dominican Republic, documented as the primary arms smuggling route into Haiti. San Jou's predecessor Joly Germaine pleaded guilty in U.S. federal court to a gun smuggling conspiracy in February 2024.

Victor Marx, who presents himself to donors and the media as a protector of Christian missionaries and children, traveled to Haiti and met personally with the man who kidnapped Christian missionaries and an eight-month-old child. He met with the leader of the organization that controls the arms smuggling route into Haiti. And he met with Jimmy Cherizier, the most wanted man in the Caribbean, a sanctioned war criminal for whom the United States offers five million dollars.

[At SHOT Show in January 2025](#), Marx described the trip publicly at the world's largest firearms trade show, standing alongside Corby Hall, while the Victor Marx Signature Series rifle was being promoted at Hall's booth. He told the crowd: sixty days ago I'm in Haiti meeting with Jimmy Barbecue, the head gang leader of all the gangs in Haiti. There's a bounty on one of his guy's heads from the FBI.

---

### **February 20, 2025 — The Weapons Order**

All Things Possible Ministries placed a purchase order with FoldAR totaling \$26,076. Multiple weapons in the order were designated ATPM Haiti Team and engraved individually with the names of specific team members. Chuck Holton, who wrote the CBN article presenting the Haiti trip as a humanitarian mission, received a personally engraved weapon. The order was placed during the active United Nations arms embargo on Haiti, which had been expanded in October 2024 to cover all arms and related equipment of all types.

A former [U.S. Marine was sentenced to 63 months](#) in federal prison in 2021 for illegally exporting firearms to Haiti in violation of the [arms embargo](#). The legal framework governing that prosecution was identical to the framework in effect when this order was placed.

---

## **April 2025 — Colorado Springs: The Final Visit**

Corby Hall drove to Victor Marx's Colorado Springs property in early April 2025 carrying two things: a proposal to save his company and a belief that the man who had married him and his wife, who had spoken over them, who had stood before God on their behalf, was still the man he thought he was.

He left carrying neither.

Marx and his COO Chaz Yandall met Hall in the hotel dining area wearing bulletproof vests. Marx explained they were breaking them in. Hall thought nothing of it. He trained Marx's bodyguard on FoldAR deployment that evening. He spent three days on the property discussing end times prophecy, underground bunkers, marriage, salvation, and the future of his company.

Marx told Hall his accountants had valued FoldAR at two million dollars including the patent. Hall had valued it conservatively at twenty million. Marx then offered to personally purchase fifty-one percent of the company. He told Hall that Sig Sauer was interested, that Daniel Horner had tested the weapon and given the thumbs up. Hall let him talk. He wanted to see where the plane would land.

Then they went for a walk.

Walking the track around Marx's property, Marx stopped. He told Hall the Israeli Defense Forces needed the weapons. Hall responded that Israel had 3,700 schools and an SRO mission made sense. Marx turned to face him.

Fifty thousand weapons. Not for schools. Not for children. For active military operations in three countries simultaneously, from a man with no documented government contract, no military authority, no ITAR registration, and a nonprofit that spends less than twelve cents of every donated dollar on programs.

Hall stared at Marx. He said nothing. He held eye contact and did not look away.

Marx told his bodyguard to step back several paces. Then he said to Hall, quietly: "Do you know I could whoop your ass right here and there's nothing you could do about it?"

Hall did not move. He did not speak. He held eye contact for approximately fifteen seconds while Marx grew visibly fidgety. Then Marx turned and resumed walking. As he did, he said: "That's why I'm never going to engage in Scripture with you."

Not a threat he was ashamed of. Not an outburst he walked back. A calculated display of physical dominance followed immediately by a spiritual dismissal. The man who had performed a binding ritual over Hall and his wife, who had stood before God and pronounced them married, threatened to assault him and then reframed Hall's composure as evidence of demonic influence.

They kept walking. Marx showed Hall a structure being built behind the house. It was not a guest cottage. It was a large underground bunker with concrete walls and firearm ports built into the concrete facing outward, combined with an indoor shooting range. Marx described it as a facility for the spiritual retooling of traumatized law enforcement officers who work child and sex trafficking cases, funded exclusively by donors.

A nonprofit leader. Building a fortified underground compound with outward-facing firearm ports on his residential property in Colorado Springs. Describing it as a trauma healing center.

Hall told Marx he would not accept any buyer who did not commit permanently to school security as the primary mission. The deal was over.

In the days after Hall left Marx's property, Marx continued calling and texting. He told Hall the weapons were not actually needed in schools. They should go to the IDF instead. Hall told him this violated everything they had agreed to from the beginning.

Then Marx sent a group message to both Corby and Melody Hall. The couple he had married. The couple he had prayed over. The couple whose business he had promoted on national television. He told them that Corby was demonically influenced because he had refused a second retooling prayer.

That was the end of the business relationship.

Hall believes the GPS tracking device was placed on his vehicle during or immediately after this April 2025 visit to Marx's Colorado Springs property. The tracking data, once received from the subpoena, will establish when the device was placed. Until then, no formal evidence has established who placed it.

Victor Marx ended Corby Hall's business relationship by declaring him possessed. He ended Corby Hall's access to his own wife by using his position as their spiritual authority to convince her that her husband's refusal to submit again to the retooling ritual was evidence of demonic influence. Melody Hall left Corby in December 2025. Victor Marx had officiated their wedding.

**The man who married them ended the marriage.**

### III. ISRAEL: THE PUBLIC RECORD

Marx's Israel activity is independently documented through [Fox News](#), CBN, The National Desk, and his own public statements. It is included here because it establishes the gap between what Victor Marx tells the public and what he tells a firearms manufacturer in private.

Within days of the October 7, 2023 Hamas attack, Marx and Eileen traveled to Israel. Marx told Fox News Digital he had been given access and placement because of his history and work in Syria and Iraq. He told the outlet he brought one thousand Lion and Lamb stuffed animals to comfort traumatized children. He appeared on Fox News, Newsmax, and CBN describing the humanitarian mission. He published a blog post on his website titled Smiles Amid Sorrow in Israel.

In early April 2025, standing on his property in Colorado Springs with a firearms manufacturer, Marx stated privately that the Israeli Defense Forces needed 50,000 guns for operations in Gaza, Lebanon, and Syria.

The same man who told Fox News he was delivering stuffed animals to traumatized children was telling a firearms manufacturer eighteen months later that he needed 50,000 weapons for active combat operations in three countries. The stuffed animals are the public face. The weapon's conversation is the private face. The gap between those two presentations is the story.

Marx's Lion and Lamb comfort toys appear in every conflict zone where he operates. Iraq. Syria. Israel. Haiti. Each toy plays programmed audio including prayers and Scripture in the local language. Each toy contains a QR code on its paw. The toys provide the humanitarian justification for Marx's travel into active conflict zones, his access to war-affected populations, and his ability to move an armed team through regions where independent access would be difficult or impossible to justify. Whether the toys serve any purpose beyond providing cover for those activities is a question federal investigators with authority over shipping manifests and cargo documentation are positioned to answer. This document does not speculate. It states the pattern.

### IV. THE AFTERNOON OF SEPTEMBER 10, 2025

In the afternoon of September 10, 2025, three things happened. They are each independently documented. I am not drawing a conclusion connecting them. I am stating what occurred, in sequence, and letting you determine what questions the sequence raises.

## **The Stolen Weapon**

On June 14, 2024, Corby Hall sold a FoldAR rifle bearing serial number 02735 to Deputy James Whitt, a law enforcement officer in Texas. The sale was documented on a notepad from the Sky Ute Casino Resort showing the FoldAR serial number, a Sig Sauer P229 Legion 9mm, and a reference number that corresponds to a subsequent police report. Both weapons were in Whitt's possession together.

In July 2024, Deputy Whitt had the FoldAR in a backpack in his vehicle. He left his back door open while stopping at a gas station to buy ice. He returned to find the backpack stolen. He filed a stolen property report with the Midland, Texas police department. The reference number on the Sky Ute notepad is consistent with that report number. Whitt never heard back from law enforcement about the stolen weapons. He had no further contact about either firearm until April 5, 2026, when Corby Hall called him to ask about the purchase.

FoldAR serial number 02735 was in unknown hands from July 2024 through at least September 10, 2025. Fourteen months. The weapon is a concealment rifle that folds to under fifteen inches, fits inside a standard backpack, and is indistinguishable from ordinary luggage in a crowded public space. It retains full ballistic performance at distance.

## **At 9:33 AM Central — The ATF Trace Request**

On September 10, 2025, at 9:33 AM Central time, Corby Hall received an email from Alyson Wareing, Firearms Program Specialist, Bureau of Alcohol, Tobacco, Firearms and Explosives, National Services Center, Martinsburg, West Virginia. The subject was a firearms trace request. The trace identifiers included a model designation consistent with a FoldAR weapon. The field marked MULTI appeared in the trace data, consistent with multiple weapons being traced simultaneously, consistent with the July 2024 Whitt theft in which both a FoldAR and a Sig Sauer were stolen together.

This was the only ATF trace request FoldAR had received in the preceding nine months.

The ATF does not send trace requests randomly. A trace request means a specific weapon was either recovered at a crime scene, found in connection with a criminal investigation, or identified as relevant to an active federal inquiry. The ATF sent this trace on the morning of September 10, 2025.

## **That Same Afternoon — Charlie Kirk Assassinated**

Charlie Kirk was assassinated at Utah Valley University in Orem, Utah on the morning of September 10, 2025. Reuters confirmed the killing. Erika Kirk was unanimously elected CEO and Chair of Turning Point USA nine days later.

Within 48 hours of the assassination, Victor Marx was physically alongside Erika Kirk. He posted a photograph of himself consoling her and captioned it: this hug and holding her is from all of you. Within 24 hours he was teasing a gubernatorial run. Within days he had Kirk's name across his nascent campaign. The man who had publicly overstated his relationship with Charlie Kirk during Kirk's lifetime used Kirk's widow and Kirk's death as the launching pad for his political career.

## **That Same Afternoon — Evergreen High School**

I live in Evergreen, Colorado. The afternoon of September 10, 2025, a 16-year-old student named Desmond Holly opened fire at Evergreen High School, critically injuring two students before killing himself. He fired approximately 20 rounds over nine minutes. The Jefferson County Sheriff's Office confirmed he had been radicalized by an extremist network online.

The school's assigned school resource officer had been on campus that morning but had left to respond to an unrelated call at the time of the shooting. Parents had raised concerns about the lack of a dedicated SRO at Evergreen High School less than 24 hours before the shooting.

***In July 2024, Victor Marx publicly committed on national television to placing a FoldAR on the back of every school resource officer in America. In April 2025, he told Corby Hall those weapons were not needed in schools. They needed to go to the IDF.***

On September 10, 2025, a school in Evergreen, the town where I live was [shot up by a radicalized teenager](#). The school had no dedicated SRO. The weapon Marx had publicly committed to placing in SRO's hands had been redirected by Marx himself toward foreign military operations months earlier.

Victor Marx has never publicly acknowledged Evergreen High School. He has never mentioned the school security mission he abandoned. He posted a photograph consoling a grieving widow and captioned it as an embrace on behalf of all of us.

### **Corby Hall's Statement on the Trace Request**

In his formal written statement, Hall addresses the ATF trace request directly. In his opinion, the trace request is not evidence of a FoldAR weapon's involvement in the Kirk shooting. He notes, however, that the FoldAR is the only rifle that can reasonably be used for such an act under the presently known circumstances, given its extreme concealability and full ballistic performance at distance. A person carrying it in a standard backpack would be indistinguishable from any other person on a university campus.

Hall makes no claim that his weapon was used in the Kirk killing. He makes no claim that Marx was involved. He presents the facts and lets them stand.

I am doing the same.

### **V. THE GPS TRACKER**

On March 9, 2026, a local technician discovered a GPS tracking device on Corby Hall's vehicle. Based on the tracking data, the device was placed during or after October 2024, in Colorado. The most probable placement window is Hall's April 2025 visit to Marx's Colorado Springs property, though the October/November 2024 visit when Hall delivered the long range rifle is also within the possible range.

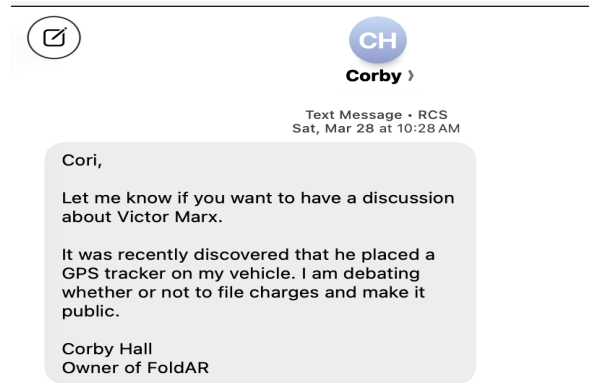
Local authorities have subpoenaed the device manufacturer for full tracking details and ownership records. As of April 4, 2026, no direct evidence has formally established who placed the device. Hall asked Marx about it directly. Marx refused to respond.

## VI. THE RETOOLING PRAYER: WHAT IT ACTUALLY IS

The retooling prayer is not incidental to this account. It is the mechanism by which Victor Marx establishes control over the people he needs. Understanding it requires understanding what it actually is, stripped of its Christian language.

In Marx's own publicly described methodology, sourced from the Eileen Marx Podcast of March 19, 2021, the retooling prayer involves a series of directed commands to demonic entities. Marx sets up a containment structure he calls a circle of judgment. He commands demons to kneel, bow their heads in shame, and answer his questions clearly, concisely, quickly, and correctly. He interrogates them: by what name do you go, how old was your subject when you were first assigned to him, what are the top three lies you have used against this person, and what is the one truth that God has been trying to tell this person that you have worked so hard to keep them from believing.

It is important to be precise about what this is and what it is not. It is not a Catholic exorcism. A Catholic exorcism is a formal sacramental rite governed by strict Church protocols, requiring diocesan approval, performed by an authorized priest, focused entirely on expelling demonic influence, with the subject as a passive recipient. It is institutional. It has an accountability structure. It can be reviewed, questioned, and corrected by ecclesial authority.

What Marx does is the opposite. It is interactive. It is interrogative. He extracts information from the demonic entity. He involves the subject as an active participant. He performs it on people he has just met, without institutional authority, without accountability, and without any church structure that has authority over him. Marx is not a member of any church with corrective authority. His spiritual authority is entirely self-declared.

What the retooling prayer more closely resembles is a cult initiation ritual. A charismatic leader establishes intimate personal knowledge of a new member through an intense private experience. The leader extracts vulnerability. He reframes that vulnerability as spiritual significance. He positions himself as the unique gateway to healing and divine purpose. The subject emerges feeling seen, chosen, and bound to the leader by a shared secret experience.

That is exactly what happened to Corby and Melody Hall on December 1, 2023. Eleven hours. Personal questions. The Columbine story extracted. Marx and Eileen leaving the room together. Returning with a conveniently prophetic dream. The retooling prayer performed on both of them. Two guns given. Comfort established. Eighteen months later, when Hall refused a second retooling and the business deal collapsed, Marx declared him demonically influenced and moved to end his marriage.

The retooling prayer is not therapy. It is not a ministry. It is the mechanism by which Victor Marx creates dependency, extracts compliance, and punishes resistance.

## VII. WHY HAITI: THREE POSSIBILITIES

This section is clearly labeled as analytical assessment. It is not a documented fact. It is my analysis of the evidence pattern. I present it because the humanitarian explanation for Victor Marx's Haiti activities has never made sense on its own terms, and Corby Hall's account makes even less sense.

The stated reason for everything is protecting an orphanage. Legitimate organizations that protect orphanages in gang-controlled territory work through the UN, the Red Cross, established Haitian civil society organizations, and diplomatic channels. They do not send an armed team carrying a one thousand yard sniper rifle with a scope camera. They do not place a \$26,076 weapons order with individually engraved team weapons during an active arms embargo. They do not ask their weapons manufacturer for fifty rifles to drop off and leave. And they do not describe their purpose to that manufacturer as going to kill the most wanted man in the Caribbean.

### Three analytical possibilities present themselves.

The first is that Marx was arming Cherizier's network. Cherizier controls the territory where ATPM operates. No organization runs anything in Port-au-Prince without his knowledge and permission. The documented operational pattern of Cherizier's G9 federation is arms procurement. The federal indictment unsealed in August 2025 describes a wide-ranging conspiracy involving individuals in the United States raising funds and procuring weapons for Cherizier's gang activities. If Marx was bringing weapons, that explains why Cherizier would extend access to him.

The second is that Marx was arming people against Cherizier or against the 400 Mawozo. He stated his purpose was to kill Barbecue. He may have wanted to arm rival groups, local militia, or orphanage protectors. But fifty rifles dropped and left with no accountability structure, no law enforcement coordination, no documented government authorization, and no follow through is not a precision counterterrorism operation. It is a weapons transfer.

The third possibility is the one Corby Hall himself has settled on. Hall believes Marx was operating with State Department sign-off and CIA coordination. He believes the entire operation was sanctioned at levels neither he nor I can see. I understand why Hall needs to believe this. This man married him. He built a weapon series with his name on it. He left a long range rifle at his house.

But here is what I know about Victor Marx from months of documented research that preceded Corby Hall's first text message. Marx's military record shows a conventional stateside communications role with no combat deployment, no foreign service, and no special operations assignment. He was a radio communications guy. Think Radar on M\*A\*S\*H.

His 45,000 rescues claim has never been independently validated by any government entity or credible third-party auditor. His mentor relationship with Charlie Kirk was fabricated from a tweet and proximity to a grieving widow. His endorsements from Flynn and Former Governor Bill Owens were fabricated.

His Skull Games operation was documented by [The Intercept](#) as targeting sex workers under the guise of fighting trafficking. His campaign finance operation harvested donor data from a memorial vigil for a murdered man.

**Everything Victor Marx has publicly claimed is either unverifiable or demonstrably false.**

Corby Hall's third possibility requires us to believe that this same man conducts lawfully sanctioned covert weapons operations in Haiti on behalf of the United States government. It requires us to believe that the one thing Victor Marx does with integrity and legal authority is run guns.

I am not able to get there.

**VIII. WHAT THE RECORD SHOWS**

Setting aside theory, inference, and everything that flows only from Victor Marx's own narrative, here is what the documented record establishes:

- Marx asked Corby Hall for fifty weapons to take to Haiti and kill Jimmy Cherizier, a U.S.-sanctioned Specially Designated National, during an active United Nations arms embargo. Hall refused.
- Marx received a one thousand yard sniper-configured rifle with a mounted scope camera from Hall and subsequently traveled to Haiti, where he met personally with Cherizier and with Lanmo San Jou, leader of an organization the State Department later designated a Foreign Terrorist Organization. San Jou is indicted in U.S. federal court for kidnapping seventeen Christian missionaries including an eight-month-old child. The rifle's current location is unknown.
- All Things Possible Ministries placed a \$26,076 weapons order designated ATPM Haiti Team in February 2025, during the active UN arms embargo, with weapons individually engraved for named team members including Chuck Holton, who wrote the CBN article presenting the Haiti trip as a humanitarian mission.
- Marx asked Hall to sell him FoldAR for the purpose of supplying 50,000 weapons to the IDF for active military operations in Gaza, Lebanon, and Syria.
- Marx physically threatened Hall on his own property, in the presence of a bodyguard, when Hall declined the IDF transaction.
- Marx showed Hall an underground bunker under construction at his Colorado Springs home with concrete firearm ports facing outward and an indoor shooting range.
- A FoldAR rifle bearing serial number 02735 was sold to a Texas law enforcement officer in June 2024, stolen from his vehicle in July 2024, and traced by the ATF on the morning of September 10, 2025, the day Charlie Kirk was assassinated. The weapon was in unknown hands for fourteen months between the theft and the trace request.
- A GPS tracking device was found on Hall's vehicle in March 2026, placed in Colorado during or after October 2024. Law enforcement has subpoenaed the device manufacturer. Marx refused to respond when asked about it.
- The ATF sent a firearms trace request to Hall on the morning of September 10, 2025. It was the only such request his company had received in nine months. That same afternoon, a student was shot at Evergreen High School in the town where I live, a school that had no dedicated SRO despite Marx's public national commitment to arm every SRO in America.
- Marx ended the business relationship by declaring Hall demonically influenced for refusing a retooling prayer, then communicated privately with Hall's wife. The marriage ended months later. Victor Marx had officiated the wedding.

## IX. THE PATTERN

Victor Marx presents one face to Fox News, CBN, the U.S. Army, and his donors. He delivers [stuffed animals](#) to traumatized children. He claims to speak at Pentagon luncheons, but after researching he spoke at one. In 2016. He [consoled a grieving widow](#) on national media. He filed petitions for governor of Colorado.

He presents another face in private. He asks for weapons to assassinate a U.S.-sanctioned terrorist. He presses for 50,000 rifles for active military operations in three countries. He gets a sniper rifle before flying to meet the man he said he wanted to kill. A GPS tracker appears on a witness's vehicle. An [ATF trace](#) request arrives the morning a prominent [American is murdered](#).

The [OSINT report](#) prepared in connection with this investigation establishes that the documentary record of Marx's military service shows a conventional stateside communications role with no combat deployment, no foreign service, and no special operations assignment. His [DD-214](#) is real. His honorable service is real. The superstructure he has built around that service, the combat mystique, the intelligence-adjacent language, the high-risk humanitarian identity, is not supported by any primary record.

The 45,000 rescues claim has never been independently validated by any government entity, third-party auditor, or credible non-subject-controlled source. His marquee claim about his life's work cannot be verified.

The Intercept independently documented Skull Games, a surveillance operation connected to Marx's orbit that used sock-puppet social media accounts, commercial facial recognition tools, and cellphone location data to target sex workers, conflating them with trafficking victims. A DOJ-funded study found the trafficking indicators used were statistically insignificant.

Joe Oltmann, a Colorado Republican Party Chair candidate and data company owner, independently traced the Dean Ackles fake Facebook account to a Colorado Springs IP address connected to Victor Marx, with over 90 posts related to 16 different accounts, in a public post dated April 4, 2026. This independently corroborates what my own research documented months earlier about coordinated inauthentic behavior connected to the Marx campaign.

Marx ran for governor of Colorado using Charlie Kirk's assassination as a launching pad, physically appearing alongside Kirk's grieving widow within 48 hours of the murder, posting the photograph publicly, and captioning it as an embrace on behalf of all of us. On exactly zero of Kirk's podcasts featuring Marx does Kirk give any indication that the men were close friends or that any mentorship existed. The relationship Marx publicly claimed was fabricated from a tweet and the grief of a widow.

I began this research asking what Victor Marx was. After months of work and after everything documented in this account, I have stopped asking that question. I am asking a different one now.

Who else has he asked for weapons? Who else has he tracked? Who else has he married, retooled, and then systematically dismantled when they said no?. And what happened on the morning of September 10, 2025, to a weapon that had been in unknown hands for fourteen months, that was manufactured by a man with whom Victor Marx had an extensive documented relationship, on the same day a prominent American was assassinated?

## X. WHERE THIS GOES

I am not a federal investigator. I am a fifth-generation Coloradan who started this research because a man was running for governor of my state and something about him did not add up.

The gubernatorial race is not the story anymore. **Victor Marx will not be the Governor of Colorado**. The evidence has settled it and the voters will settle it formally.

What is not settled is everything else.

The question of what the ATF was tracing on the morning of September 10, 2025 has never been publicly answered. The weapon traced had been stolen fourteen months earlier. Its whereabouts during those fourteen months are unknown. The manufacturer of that weapon had an extensive documented relationship with a man who publicly and immediately benefited from Charlie Kirk's death. These are not conclusions. They are documented facts that raise questions only federal investigators with subpoena authority can answer.

The FBI's Miami field office is actively investigating Jimmy Cherizier's U.S. network. The federal indictment describes a conspiracy involving individuals in the United States raising funds and procuring weapons for a designated terrorist organization. Victor Marx personally met with Cherizier. Weeks before that meeting, a long range sniper-configured rifle had been left in Marx's possession. Weeks after that meeting, a \$26,076 weapons order designated ATPM Haiti Team was placed, with weapons engraved for named team members including the journalist who presented the trip as humanitarian.

The ATF is investigating the firearms used in the killing of Charlie Kirk. A firearms trace request was sent on the morning of that killing to the manufacturer of a weapon class that Marx had access to, a weapon stolen fourteen months earlier and unaccounted for since.

Local law enforcement has subpoenaed the manufacturer of a GPS tracking device found on the vehicle of a witness who documented in writing that Marx asked him for weapons to commit murder.

The United Nations arms embargo on Haiti makes it a federal violation to supply arms to Haiti without authorization. A documented \$26,076 weapons order with Haiti team engraving was placed by All Things Possible Ministries in February 2025.

[OFAC regulations prohibit U.S. persons](#) from engaging in transactions with or for the benefit of Jimmy Cherizier without an approved license. No such license has ever been publicly identified for Victor Marx or All Things Possible Ministries.

This document is a research record. It is not a verdict. Everything in it that flows from Corby Hall reflects his own firsthand written account, provided voluntarily, signed, and certified. Everything that flows from public records is documented and sourced. Nothing has been fabricated, exaggerated, or inferred beyond what the evidence supports.

The appropriate next steps are legal, not social media. An attorney. Then the appropriate federal agencies. This document is the central reference point for those conversations.

Victor Marx is not going to be the Governor of Colorado. But the questions this document raises are not gubernatorial questions. They are federal questions. And they deserve federal answers.
